

**ONCHAINMONKEY**  
**OFFICIAL RULES FOR DRAWINGS**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** Any drawings done by Nfinita Inc., d/b/a Metagood (“Sponsor”) are open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older. Void where prohibited. By participating in any drawing by Sponsor (“Drawing”), entrants agree to be bound by these Official Rules (“Official Rules”) and the decisions of the Sponsor, which are binding and final on matters relating to any Drawings. Drawings are subject to all applicable federal, state and local laws. Drawings are in no way sponsored, endorsed, or administered by Discord or Twitter. Discord and Twitter are completely released of all liability by each entrant in any Drawings.

Any future Drawings will be announced by Sponsor on official Sponsor channels such as Twitter and Discord.

**TO ENTER:** The initial snapshot takes place on 7:02 p.m. EST on January 31, 2022 (00:02 UTC on February 1, 2022) at block #14116777 on the Ethereum blockchain (the “Snapshot Time”).

An OCM Dessert is a tradable ERC-1155 token required to create a Karma. An owner of an OCM Genesis NFT (“OCM Genesis”) who has it in their non-custodial wallet at the Snapshot Time, is entered into the Drawing to be airdropped one OCM Dessert per one OCM Genesis held. An owner of an OCM Genesis held in a custodial wallet as of the Snapshot Time has to take additional verification steps [linked here for Nifty Gateway](#), which if successfully completed, will enter that holder into the Drawing.

There will be a maximum limit of one (1) Drawing entry per OCM Genesis.

Compromising, stealing private keys, unauthorized access to, or otherwise hacking into another party’s wallet may result in voiding the entry. Use of robotic, automatic, or macro devices is not valid for entry. Any entry that is submitted with the use of a robotic, automated or macro device will be void.

**WINNER SELECTION AND NOTIFICATION:** The Drawing will use a verifiable random function to randomly assign a Dessert (D1, D2, D3) to each eligible OCM Genesis wallet address that held an OCM Genesis as of the Snapshot Time. The Drawing will take place at approximately 9:30 p.m. EST on February 10, 2022 (2:30 UTC on February 11, 2022).

After the Drawing the prize distribution of D1, D2, and D3 desserts to each OCM Genesis will be publicly available on-chain by the smart contract used. The Desserts will then be airdropped to the receiving wallets at some time during the 24 hr period after the Drawing occurs, when gas on the Ethereum blockchain is low.

Sponsor shall have no liability for any winner notification or Dessert airdrop that is lost, intercepted or not received by a potential winner for any reason. If the prize or prize notification is returned as unclaimed or undeliverable to such potential winner or claimed by multiple holders of the same OCM Genesis, such potential winner will forfeit his or her prize. If any potential

prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified and an alternate prize winner may be selected. **The odds of winning a specific type of Dessert depends on the distribution of Dessert prizes stated below.**

**PRIZE(S):** Up to 10,000 Desserts are available as prizes, 1 for each OCM Genesis in the 10,000 OCM Genesis collection. Approximately 55% of Desserts are classified as D1, approximately 45% of Desserts are classified as D2, and only 15 Desserts total classified as D3.

You acknowledge that the price of a Dessert token or NFT can fluctuate and assume all risks associated with any price fluctuation of your Prize. Sponsor makes no guarantee as to the future value of any token or NFT and is not responsible for price fluctuations in the value of any token or NFT.

You must have a crypto wallet to claim a prize. Sponsor is not responsible for any fees associated with creating a wallet, nor any other transactions involving any token or NFT, including, but not limited to purchasing/transferring/selling/liquidating and/or converting an NFT.
